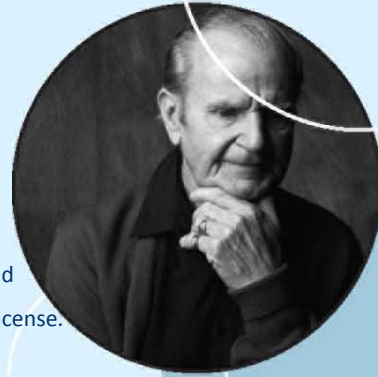


# Career Opportunities

- ◆ **Social Services Director, LSW**
  - ⇒ Head of our Social Services Department, works to ensure that the appropriate needs and interests of each resident are met. They provide social work services of assessments, counseling, discharge planning, etc. Requires current state license for social work.
  - ⇒ *Regular schedule: 8am—5pm, 40 hours/week*
- ◆ **CRA Supervisor/Instructor and Quality Educator**
  - ⇒ This position consists of a few major roles: Nurse Educator, CRA Supervisor, and QAPI (Quality Assurance, Process Improvement)/Risk Management. This is a management position that is a part of our Team Leaders group. Requires RN license.
  - ⇒ *Regular schedule: 8am—5pm, 40 hours/week*
- ◆ **Laundry Assistant: Washer**
  - ⇒ Gathers, cleans, and replaces linens and other laundry supplies to specified areas throughout our facility. Previous laundry, housekeeping, or long-term care experience appreciated.
  - ⇒ *Shift Available: 6am—2:30pm, 40 hours/week, scheduled every other weekend*
- ◆ **Housekeeper**
  - ⇒ Responsible for the cleanliness of our resident rooms and common areas. Duties include: dusting, vacuuming, sweeping, mopping, etc. Previous laundry, housekeeping, or long-term care experience appreciated.
  - ⇒ *Shift Available: 6:30am—3pm, 40 hours/week, scheduled every other weekend*
- ◆ **CRA**
  - ⇒ Accountable for the primary care of our residents. Duties include but are not limited to: transporting, feeding, bathing, toileting, etc. Prior CNA or caregiving experience appreciated. Position requires current state license.
  - ⇒ *Shifts Available: 7am—3:30pm, 7am—7:30pm, 3—11:30pm, 4—9pm, 4pm—4:30am, 7pm—7:30am, regular schedules with as little as 8 hours/week to as many as 40 hours per week, opportunity for overtime may be available*
  - ⇒ Differential pay available for Special Care Unit, PM, and overnight shifts
- ◆ **CRA Helper**
  - ⇒ The CRA Helper, like the CRA, helps to care for the resident but focuses in on assisting at meal times as well as accompanying residents to appointments outside of the facility. Prior CNA, caregiving, or feeding assistant experience appreciated. Requires current state license.
  - ⇒ *8am—5pm, 8 hours per week, every other weekend*
  - ⇒ Differential pay available for Special Care Unit, PM, and overnight shifts
- ◆ **LPN**
  - ⇒ The LPN, under the supervision of an RN, is responsible for overseeing the overall health of the residents in his or her assigned area and monitoring the residents to make sure they are receiving proper care. Prior nursing or long-term care experience appreciated but we hire new graduates as well. Requires current state license.
  - ⇒ *Shifts Available: 7am—7:30pm, 3—11:30pm, 7pm—7:30am, PRN, regularly scheduled every third weekend, opportunity for overtime may be available*
  - ⇒ Differential pay available for Special Care Unit, PM, and overnight shifts
- ◆ **RN**
  - ⇒ The registered nurse is responsible for overseeing the overall health of the residents in his or her assigned area and monitoring the residents to make sure they are receiving proper care. Prior nursing or long-term care experience appreciated but we hire new graduates as well. Requires current state license.
  - ⇒ *Shifts Available: 7am—7:30pm, 3—11:30pm, 7pm—7:30am, PRN, regularly scheduled every third weekend, opportunity for overtime may be available*
  - ⇒ Differential pay available for Special Care Unit, PM, and overnight shifts
